They will work under the supervision and guidance of Shri Agrawala and other competent auditors and supervisory persons as assigned by him. H.K. Agrawala and Co is a reputed firm with expertise and is able to train the students and also able to assist them in placement or further studies. The Firm is known to as the auditor and financial consult for most of the Don Bosco institutions of our Province. The internship plan is an effort, for the first time, to assist the students on completion of their B.Com final exams to acquire hands-on skills necessary to meet the requirements of getting good jobs. We are trying to address the gap between theory and practice, academic knowledge and practical experience of workplace needs. The program also intends to address the needs of many institutions to have competent and trained accountants. Any student discontinuing the internship program in between will not be eligible for the amount of Rs. 1000/- deducted monthly and the total of Rs. 12,000/. The students who complete the entire program successfully will be given a certificate jointly issued by the Audit Firm and the Don Bosco College. This will help the students to get good jobs.
